Campground Rules

This property is privately owned. By signing below, the registered camper/family/guests accept all privileges with the understanding that he/she does hereby release the campground, its officers and employees of all liability for loss or damage to property and injury to his/her person arising out of use of our campground and agrees to indemnify the campground, officers and employees against claims resulting from loss or damage to property or injury to the person of any member of the registered campers family.

**TENT CAMPING:** Tent camping is allowed in designated sites in JTSC Campground during the months of April – October.

- The maximum stay for tent campers is 14 Days in a twelve-month period.
- Tents may not be used for storage. Makeshift tents and clotheslines are not allowed.
- One tent per campsite.
- No electrical appliances allowed in tents to include refrigerators, air conditioners or heaters.

All RVs must be 15 years or newer and must be well maintained and in excellent overall condition and in good repair, with current licensing and registration. Exception can be made upon inspection by JTSC Staff. All trailers must always be accompanied with a tow vehicle. Sites are limited to 1 camping unit and 1 vehicle. Maximum Stay for an RV is 30 days at a time up to 90 days in a twelve-month period with a minimum of 24 hours vacated between stays.

Sites, our camp staff works hard to keep sites clean and free of debris, please help by avoiding clutter and eyesores such as boxes, car parts, tools, wood, appliances, or other item(s) outside or left on table tops.

Vaccinated Pets are welcome up to 2 per site. All pets must be registered at check-in and must always be on-leash and cleaned up after promptly. Please do not leave pets unattended at the camp site. Barking must be controlled. No Aggressive dogs or breeds allowed. Cats are pet too and must not roam free.

Rest rooms are available when not restricted by the County Health Department. We are not in control of restriction and only self-contained camper are allowed during these times. Please do not flush feminine products into our sewer system. Washing dishes or clothes in campground bathrooms is not permitted. Please pick up after yourself and your guests.

Garbage – Please tie trash bags and place in the dumpster near the patio at south west corner of the campground. Only campground generated trash is permitted. No commercial, business or outside trash is acceptable. Any violation will result in the additional dumpster fee up to \$275.00 per use.

Vehicle Repairs are not permitted or allowed on campground property any vehicle maintenance required please contact staff for guidance.

No Business activity allowed in campground, including subleasing or listing of any vehicle, RVs or items for sale.

Blackout Dates. No recreational campers are permitted during first weekends in April and October. JTSC hosts the Annual Gem and Mineral Shows during those weekends and no exceptions will be made. Please adjust your stays accordingly. Consult our website under "Other Events" or call for exact dates.

Campfires are allowed in approved fire pits, and within County guidelines. Please contact camp host for available fire pits. To control wood boring pests, out of state firewood is discouraged. Wood is available on site at a reasonable cost as well as at local stores. Burning of garbage is not allowed.

Firearms, explosives, and pyrotechnic devices are not permitted on site.

Park Use: We back up to one of the area's best community parks. it has a skate and water park, basketball and tennis court, children's playground with a gated entrance from our campground. Please respect the facilities and accompany any minors to help them enjoy this service, please see host for gate keys.

No loud arguing, fighting, violence, or other disturbances are tolerated. Please report any all incidents to staff or 911 for intervention and or personal removal from property.

Payment for services whether for goods or accommodation are required in advance, any thief or overstays are reported to local law enforcement for resolution.

The camping fee includes up to 4 people present at check-in, one camping unit per site and one vehicle per site. Campers must pay for extra people and or extra vehicles at check-in. By signing, you are responsible for everyone at your campsite and must be at least 21 years of age. Violators may be removed from the property without a refund. I have read all the above and agree to comply with all campground guidelines.

Laundry Room is for registered campers only. Please do not leave item in machine once the cycle has completed. Chance and soap are available by machines on south wall. Washing dishes is not permitted in utility sink. See camp host for door combination. We are not responsible for item left unattended.

For emergency services Fire, Medical, and Police dial 911 please state address when calling from a cell phone.

All site service, information, or non-agency related emergency can be reported to the camp host at 760 366-2915 option 1 if no answer call back to option 2.

**Check In: 1:00 pm – 5:00 pm. Please call us if you will be arriving after 5:00 pm.**

**Check Out: 11:00 am**

**Quiet Time: 10:00 pm until 8:00 am**

**Speed limit is 5 Miles MPH in all areas of the Park.**

**Any recreational vehicle(s) or Tent Camper(s) may be removed from the premises for the reasons specified in Sections 799.22 and 1866 of California Civil Code. San Bernardino County Sherriff Department 760 366-4175**

**Overnight guests must register at the office and are subject to a \$5.00 fee per person per night. Visitors under the age of 18 must be accompanied by the guest ALWAYS while in the park.**

**If you observe any activity you believe to be of concern, call 760 366-2915 24 hours a day. (No soliciting is allowed.)**

**Current ID's Required at Check-in**

**Campsite rates are posted on our website and are in effect between October 15 through April 15 Off season site are available on a limited bases for stays 7 days or more at a 25% discount . Check with camp host for availability.**

**I understand my registration constitutes a temporary recreational use of our property no permanent residency or landlord tenant relation is implied or exists.**
